Hong Kong mediation Ordinance

Civil Mediation Council Elections

The results of the CMC Board Elections have now been announced.

We are pleased to confirm that The Academy of Experts has been re-elected to the board for another term as a provider organisation.

Both TAE and ADR Group were re-elected to the Board of the Civil Mediation Council for a three year term ending in 2015.

In the elections for individuals Paul Randolph and David Richbell were elected in a closely contested election.

As well as serving on the Board itself TAE is a member of both the CMC Communications and Accreditation Committees. In Hong Kong active steps are being taken towards the introduction of a Mediation Ordinance. A Bill was introduced to the Legislative Council in November 2011. It is proposed that it will apply to all mediations taking place in Hong Kong or under any agreements that stipulate Hong Kong Law. They have defined mediation as follows:

" A structured process comprising one or more sessions in which one or more impartial individuals, without adjudicating a dispute or any aspect of it, assist the parties to the dispute to do any or all of the following –

a. identify the issues in dispute;

b. Explore and generate options;



c. Communicate with one another;

d. Reach an agreement regarding the resolution of the whole, or part, of the dispute."

The Bill also looks at the issue of confidentiality and defines what is meant by mediation communication for this purpose and excludes the agreement to mediate as well as the final settlement.

It will be interesting to see how this Bill progresses and how it is viewed by the mediation communities as a whole.

Solving Disputes in the County Courts

Solving Disputes in the County Courts - The Government on 9th February published its long awaited response to the consultation which closed last June. The publication which was due at the beginning of the year was delayed several times.

In terms of Academy Members the main areas that are of interest are those relating to mediation. It should however be noted that there will be changes to the limits for small claims - the levels for the other tracks will remain unchanged. In the ministerial forward it is noted that the proposals being taken forward include:

Expanding mediation by building on the mediation service that has proved so popular with those who have small claims for less than £5,000. This service has received very high levels of customer satisfaction, and has been used to resolve almost 15,000 disputes over the past two years. And, since it is primarily a telephone-based service, that

Family Justice Review

Another Government response has recently been published – this time in response to the final report of the independent family just review which was chaired by David Norgrove and was published on 3rd November 2011. The Government has decided to accept the majority of the review's recommendations in full.

The family division is a major user of experts and many of the recommendations will be welcomed by experts.

The quality of instructions is a regular problem. Therefore the acceptance of the recommendation that Solicitors professional bodies should work with representative groups to provide training opportunities for solicitors on how to draft effective instructions for expert evidence will we are

The review also recommended Judges should direct the process of agreeing and instructing expert witnesses

as a fundamental part of their responsibility for case management. Judges should set out, in the order giving permission for the commissioning of the expert witness, the questions on which the expert witness should focus. The Family Procedure Rules Committee will now consider how best to implement this either within the current rules or by creating new rules and changes.

A further pilot of the use of multidisciplinary teams will be taken forward with work starting later this year. The use of teams was a suggestion that came originally from the 'Bearing Good Witness' consultation paper by the Chief Medical Officer and was unsuccessfully piloted.

There will be a review of the current arrangements LSC to experts and whether in the long term it would be appropriate to contract direct with experts.

means up to 30,000 parties that have been able to resolve their disputes without ever having to travel to court.

- □ With the introduction of automatic referral to the small claims mediation service, the MoJ want to see this service expand to offer mediation to all 80,000 disputes that are currently allocated to the small claims track.
- Expanding the small claims track, initially to £10,000, since many of the cases that fell into the small claims track back in 1999, are now routinely treated as fast track cases with associated costs.

Expert witnesses accused of 'industrial scale perjury'

An expert witness has been accused of lying to the court and falsifying data and evidence to aid their client.

Helen Whysall of Autofocus was given a twenty-eight day suspended sentence after a court heard she lied about calling several High Street hire car companies in order to find the going-rate for the hire of a top-end Mercedes car which would only have been available at a small number of companies. It now transpires that there may be another 20,000 similar cases.


