need any further encouragement, you will be pleased to hear that there have already been many members who have upgraded and (within the first month since the launch) over 25 members previously without an internet register entry have seen sense and joined.

In summary, the internet register is a notto-be-missed facility for all members. It is open to you to sell yourselves as experts at a very modest cost and I hope that steps will be taken shortly to market its existence in the public domain to help people find you as their expert of choice.

SCL Report on Expert Evidence

Internet Register

Do's and Don'ts

The new website has given members the ability to edit their own contact details and 'Brief CV/snapshot'. Members have been eagerly taking advantage of this excellent facility with varying results so we have put together a small guidance note.

The full note will shortly be available on the website in the member section - a short summary is shown below.

In general your snapshot should be a prose section of 150/300/450 words giving a rounded description of your expertise and experience. Details such as address and qualifications are listed separately.

Do:

- Describe the work you do.
- ☐ Describe your Expert Witness Experience.
- List any notable cases you have been involved with if they are no longer live and in the public domain.
- Be extremely careful if you quote praise you have received ie 'Mr Smith is an excellent Expert'.

Do not:

- ☐ Put your qualifications in they are already shown separately.
- ☐ Put in your address these are already shown separately
- Put in contact details of third parties as this may cause data protection issues.



Compliance

By following these guidelines for the snapshot we can ensure that the website has a consistent look and feel and that TAE can be confident that members are keeping within the range of their TAE Accreditation.

All member entries and amendments will be moderated by TAE prior to going live on the website to ensure compliance.

Intellectual Property Office

The Intellectual Property office has recently published a response in relation to the Call for Evidence on its Mediation Service. It states that they will:

- continue to offer its Mediation Service and will effect changes by March
 2013 to increase its appeal and value to SMEs for resolving IP disputes;
- undertake a further short informal review of the Service in late 2014 to consider the effect of any changes;
- work with stakeholders and across Government to ensure a coordinated approach to increasing the use of mediation to resolve IP disputes.

Hong Kong Mediation Ordinance will come into effect on 1st January 2013

The Mediation Ordinance provides a regulatory framework to remove impediments to the development of mediation - among other things to give statutory effect (in addition to any contractual or "without prejudice" considerations) to the confidential nature of "any mediation communication" made before, during or after a mediation.



The Ordinance applies to mediations conducted wholly or partly in Hong Kong or where the agreement to mediate is governed by Hong Kong law. The Ordinance also applies to the Hong Kong Government and its statutory bodies.
