The 25th Anniversary lectures and other evening meetings

There has been a short pause for the summer with the 25th Anniversary series of lectures. We are moving seamlessly on with other lectures and the following are dates for your diary. Sir Alan Ward will be presenting an ADR-focussed lecture on 9th October; Colin Edelman QC will be speaking on Expert Evidence in Arbitrations on 30th October and Clive Zietman will talk about Financial Sector Litigation in on 13th November.

I am also delighted that Michael Cohen, our Chairman Emeritus, has agreed to present a lecture based on the history of The Academy over the last 25 years. It was discussed by Council as a most fitting way to close out the 25th Anniversary series and I am sure that it will prove to be a most popular event. We are still discussing the format and date, which will be later this year, but we will inform all of the details as soon as possible.

As part of our continuing regular evening meetings, in mid-June, member Simon Clarke gave a fascinating presentation on his role as an expert in the repair of the Grade 1 listed structure, the Statue of Eros, in Piccadilly. This was a somewhat different subject matter than is the norm, but it was greatly appreciated by those who attended and we will certainly consider similar formats in the future; all volunteers are welcome to present to us your experiences as an expert! In addition, later that month, the Academy held a joint evening meeting with the Northern Ireland Chapter of the Irish Branch of the Chartered Institute of Arbitrators on the subject of problems faced by experts.

Coming up, our good friend and Chairman of



the Vetting Committee, Colin Passmore, will also be speaking on the subject of Privilege on 24 September.

Consultations

Since the last update, there have been two major consultations issued by the Ministry of Justice (MoJ). The first, which I mentioned in the last update, was entitled "Transforming Legal Aid - delivering a more credible and efficient system" and had an excellent response and provision of views from over 150 members and over 20 members attending a short notice meeting with representatives of the MoJ. I congratulate Nicola Cohen not only in taking the initiative with regards to coordinating and securing the meeting with

MoJ but also in dealing with this influx of very valuable contributions and thoughts and for drafting a quite excellent paper which we hope will be of benefit to MoJ.

This was followed up with a further consultation entitled "Standards for Expert Witnesses in the Family Courts in England and Wales". Although the proposals currently relate to Family issues, particularly in proceedings relating to children, it is possible in the future that if the standards are adopted they will affect all Experts in Family matters in due course, and maybe even wider. It is quite possible that the Standards will come into force later this year.

Training Courses

The first masterclass on cross examination, in conjunction with the SCL, on 22nd May 2013 was a sell out and it is intended to repeat it again in the future. Courses, provided by ARACS on behalf of The Academy, continue to be arranged to meet demand and are well attended. Please do keep a close eye on the Academy website for details of courses and dates. There are at least twelve different courses on offer between now and the end of the year and three in Hong Kong.

Expert Determination Assessment


More and more Experts are being asked to undertake Expert Determinations and TAE is being asked more frequently about the Register of Expert Determiners.

Assessments for entry to the Register take place three times per year. The process is online (via email) and involves a simulated determination. If you have undertaken ED training but have not yet applied for the Register why not call the office to discuss the process?

New Lord Chief Justice

Sir John Thomas has been named as the new Lord Chief Justice, replacing Lord Judge as head of the judiciary of England and Wales.

Sir John, currently president of the Queen's Bench Division, will take over the role in September. He was recently involved in many high-profile cases including those of Abu Hamza and Julian Assange.





European Online Dispute Resolution Directive

A European Union (EU) Directive on ADR for consumer disputes and an EU Regulation on online dispute resolution (ODR) for consumer disputes were adopted by all EU Member States on 22 April 2013.

The Department for Business, Innovation and Skills advised that both the Directive on Alternative Dispute Resolution and the Regulation on Online Dispute Resolution have now been published in the Official Journal of the European Union.

The texts came into force on 8 July and the UK Government now has two years to implement the ADR Directive (July 2015), with the ODR platform becoming operational six months later (January 2016).
