I would like to thank our Judicial Committee for the work that it put in to developing this standard.

#### CV's are more than just a marketing tool

#### New Model CV set to help the Courts & Experts

The Chairman's Lunch in January saw the official launch of the new Model CV for Experts to use in their reports. Designed to be used in conjuction with or as a part of the Model Form of Expert's Report the aim of the new model is to help judges.

The Judicial Committee, which TAE President Lord Saville himself chaired, prepared the Model CV in response to an increasing number of concerns raised by senior judges about the quality and content of CV's in the reports they were seeing. CV's are often too long and do not contain information that would assist the courts.

- □ The Model Expert Witness CV is designed to help the courts.
- □ The Model Expert Witness CV **should not** be confused with your marketing CV which will be a separate document.

#### Above all - be accurate

The importance of an accurate CV was highlighted recently by an American case where an accountant has been experiencing the fallout for 'lying' on his CV. His CV claimed that he had received an MA, Accounting from Brooklyn College in New York. However, Brooklyn College only offers a MS in Accounting - there is no record of the expert completing such a degree.

It is not yet known whether or not this was a typographical error or a deliberate lie. In any event the Expert in question has already been removed from a number of cases on which he was acting despite his own instructing attorney saying of him "His testimony to the best of our knowledge was truthful based upon the information that he had ... He is a very good forensic accountant, and he knows his stuff".



#### **Academy Qualifications**

As well as degrees most experts are members of one or more professional institutions.

It is not uncommon for these bodies to either change their name or the designations (and subsequent post-nominal letters awarded) of their members. Do remember to keep up to date and also bear in mind that as this might be confusing to instructing parties you should present a clear indication or explanation where this has happened.

Whilst we can not advise on other bodies' qualifications we can certainly do so for The Academy of Experts which changed its post nominal letters in 1995. Twenty years on we still see regular references to the British Academy of Experts and members showing their qualifications as MBAE!



TAE Expert Witness qualifications are as follows:

Fellow:	FAE	- FBAE pre 1st July 1995	
Member:	MAE	- MBAE pre 1st July 1995	
Associate (AMAE):	AMAE	- introduced post 1995	
Associate:	No designatory Letters		

Note also that when referring to The Academy the correct format is either 'The Academy of Experts' or in shortened form 'TAE' - note the capitalisation.

#### Keep us up to date as well

In addition to your CV it is also important to keep your online presence up to date as this is frequently the first place a potential client or the 'other side' will look for you.

Although keeping up to date on all of the different websites and directories you subscribe to can be time consuming you should always ensure that your TAE online entry is up to date. More and more solicitors (and even potential employers and recruitment consultants) are now using our register to confirm that an expert witness is who they say that they are.

#### Updating your TAE online entry

- As part of your formal TAE accreditation we must receive proof of any additional or changed qualifications.
- If you do have a change to make to your qualifications please email us with a copy of your certificate or letter or entitlement so that we can validate and amend your record.
- Remember that you should not list qualifications within your online CV as we will remove them because they must be validated and will be listed separately.
- Address changes or changes to your online CV you should make directly on the TAE website.

#### **Treasury Solicitor's Department**

#### New incentive to Mediate? Price of Justice increases

With effect from Monday 9th March 2015 fees for issuing civil claims over £10,000 are increasing by up to 622%.

Value of Claim	Old Fee	New Fee	Increase
£000's	£	£	%
20	610	1,000	64%
40	610	2,000	228%
90	910	4,500	395%
150	1,315	7,500	470%
190	1,315	9,500	622%
200	1,515	10,000	560%
250	1,720	10,000	481%

Predictably there has been much discord and active protest from the legal profession regarding what is a very large increase in issuing fees. However, from an ADR point of view be it mediation, Expert Determination or otherwise, this can only add further weight to the 'quicker - cheaper - better' argument.

#### Timetable for Scottish court reforms announced

Justice in Scotland is set for a big shake-up akin to the changes in England & Wales since the Woolf report. Lord President Gill has announced the timetable for the implementation of the changes brought by the Court Reform (Scotland) Act 2014. Key dates are:

#### July 2015

appointment process for first Summary Sheriffs to be put in hand

#### September 2015

- Sheriff Court to hear claims with a value of up to £100,000
- New Scotland-wide Personal Injury Court to open in Edinburgh
- Establishment of a new permission stage for judicial review
- New Sheriff Appeal Court opens for new criminal appeals

#### January 2016

New Sheriff Appeal Court to start hearing civil appeals

#### Spring 2016

□ Simplified procedure for claims up to £5,000
