If you haven't done so already, please do take the time to do this, there is a link at the bottom of this report (page 4).

The survey hasn't just gone out to TAE members - we would like as many experts as possible to complete it. The information we gain will be very useful in providing guidance for those who may be considering reviewing their fees in relation to the 'current market' and certainly in considering the issues around fixed fees. We are especially interested to hear about how fixed fees may be likely to affect you, so please do let us know.

As experts working nationally and internationally, we come across a range of

## **Garden Room**


The Garden Room, with its aspect looking out over the Walks is a calming setting for even the most stressful of meetings.


