Evening Meeting Catchup?

A member writes...

I am a Chartered Engineer and Chartered Surveyor - now retired. I also served for over 25 years as a Magistrate - also now past the retirement age.

I have become embroiled in civil disputes because I have been involved extensively in appraising buildings and construction problems. In many of these cases disputes arose and so in many cases the parties resorted to legal determination to resolve their differences.

So I often found myself trying to help resolve the dispute by some form of negotiation, but when that didn't work I ended up as an Expert Witness for one or other party. It was from this background that I found the TAE invaluable, particularly its the advice given in the regular issues of 'update' and also the 'written guidance' that appeared on its website eg CPR 35 revisions explained.

It did advertise interesting lectures, but they were almost exclusively in London!

On this account, I felt rather excluded by TAE, it seemed to be 'London centric'; except for 'update' and TEDR - both excellent publications - I got little more from TAE - though I did attend the Grays Inn Garden Party a number of times and that was an excellent 'do' - if the weather was good.

However, my biggest discovery - and one of the very best innovations by TAE - was the decision in 2013 to record and produce on line videos of some of their 'special' lectures by eminent legal experts, including senior Judges, who explained clearly and from their experience - current legal developments that effect Experts.

There are eight in the series at present with more being added. They range from practical subjects like 'Marketing your Mediation Practice' through 'Experts' Liabilities' to 'Costs Explained' - and the 'Jackson Reforms'. All subjects highly relevant to all Expert Witnesses, and now available to all members, where ever they live.

Experts in the news

Court raps SFO for use of 'inexpert' expert witness

The Serious Fraud Office has been criticised by the Appeal Court for appointing an expert witness who "lacked expertise".

Lord Justice Gross warned SFO prosecutors the Appeal Court judges viewed the SFO's use of Saul Haydon Rowe as "a debacle".

He appeared in the trials of former traders for allegedly rigging Libor.

The comments were made at a hearing brought by Alex Pabon, found guilty of conspiracy to defraud last year. The Libor trials saw a number of traders accused of rigging the key interest rate, which is used to set interest rates charged between banks.

Lord Justice Gross told SFO prosecutor James Hines QC:

"It's not a matter to be downplayed when the Crown in a major prosecution calls a witness who is wholly out of his depth.

"We take a very serious view of what in the judgment we will describe as a debacle, whatever the outcome. "We want to know how did it come about that he was instructed when he lacked expertise? We are very concerned as to how he can have been instructed, the due diligence, and how it came to light.

"We are troubled by it."

This case once again highlights the need for both proper accreditation and training for both experts and those using experts in the courts.

Members will take encouragement that the expert in this case was **not** an Academy member.

Update to CPR PD 35

Changes to Hot-tubbing procedures.

The latest update to CPR (93rd Amendment) has just come into force. Affecting experts is a change to PD 35 relating to hot-tubbing (concurrent evidence). Whilst most of the changes are mainly clarifications of the existing rule there is now an additional provision for the court to set the agenda where previously this had been left to the parties.

As hot-tubbing is becoming a more frequent occurance members should take careful note of the changes.
