Business as usual

GDPR

It would appear that now we are well into the holiday period the heatwave has ended and we are back to our more commonly expected summer weather with a good dousing of rain, i.e. business as normal.

Fortunately, the sunshine held for the Gray's Inn Treasurer's Reception. This event was well attended by The Academy and was a very enjoyable evening. Many thanks to those who represented The Academy with a special mention to our Australian member who must have travelled furthest to get there.

One exception to business as normal though is

the introduction of GDPR. I suspect many feel

we are only just getting started! Unfortunately,

the time required to understand what is

time putting ever more pressure on everyone.

concepts that are quite foreign to what was

new language and

foreign to what was previously 'normal understanding'. For many this is a major task all in the name protecting 'data'.

Whilst it is unlikely to cause serious problems for organisations who deal with their data in a responsible way it is now important to be seen to be dealing with it in accordance with the new regulation.



The Academy has decided to tackle this need for compliance head-on and top marks to Michael Cohen and the Team at Gray's Inn for jumping straight in and getting with these issues.

Judicial Criticism

What should also be an exception to 'Business as usual' is the mounting criticism of experts by the Judiciary.

Academy members have not generally been the target of such criticism but the situation is still a cause for concern and a warning

for everyone to be meticulous when preparing reports. Interestingly, many of us receive reports from other experts that fall short of the mark on content, typically sections such as the Expert Declaration or Statement of Truth are missing, and yet there is no mention of this throughout the proceedings.

This is no excuse - Members are advised to pay particular attention to the requirements of the Procedure Rules and Guidance. One point which should be quite simple is to ensure that the CV is correct and accurate.

TAE Seals - Marketing

Many members will remember the red seals, in the form of round stickers, that were issued to them on joining. The Academy has now progressed and updated these seals a personalised version of which is now available in an electronic format.

Remember that to be eligible to use the seals you must be a Full Member or Fellow - for those Associates who have been Academy Members for a number of years this may well be an incentive to apply for upgrade.



General

Members on the TAE online register will have received their renewal notifications in the last few weeks.

The Register is a valuable resource for members and users of Experts. More and more instucting lawyers are using the register to check that potential experts are properly accredited.

If you are on the register you should ensure your details are up to date. If you are not on the register perhaps you should be considering it.

In particular if your qualifications have changed, be it an additional professional membership or removal you should ensure we are updated. One member found out recently that not doing so can have disastrous results. Having been appointed to a high profile enquiry, it was subsequently discovered that not only was his TAE entry incorrect but his personal website showed him with qualifications he was not entitled to resulting in considerable professional embarrassment.


