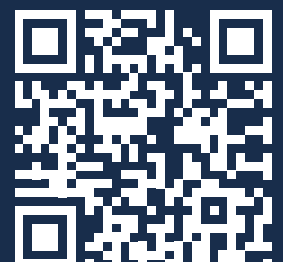

EXPERT PRESENTATIONS IN ARBITRATION

Presenting effectively is a vital skill for any Expert, particularly in arbitration where much of the evidence is delivered through oral and visual presentation. This intensive one-day course is designed to build confidence, clarity, and impact in how you present your evidence and opinions.

The course starts with an exploration of the Role & Responsibilities of the Expert, detailing the definition, qualifications, types, and primary uses of experts. The course emphasises understanding the legal requirements and guidelines practitioners must adhere to.

A significant portion of the course is committed to the crucial aspect of Conference with Counsel, encompassing objectives, preparation techniques, and the intricacies of effective collaboration with legal counsel. The Meeting of Experts segment delves into its objectives, preparation, guidelines, and the importance of memorandums in these meetings.

The section on The Giving of Evidence describes the fundamentals of evidence and offers a thorough breakdown of the Expert's Report. Participants will learn about the different types of expert reports, their readership, and the essential steps to embark on before initiating the report. This section also highlights potential pitfalls and challenges faced during the preparation process and offers solutions to handle them effectively.

The Aims and Features of the Evidential Report module stresses the significance of brevity, layout considerations, including appendices, typeface, margins, spacing, and pagination, and in particular the requirements of the Rule 20 Report.

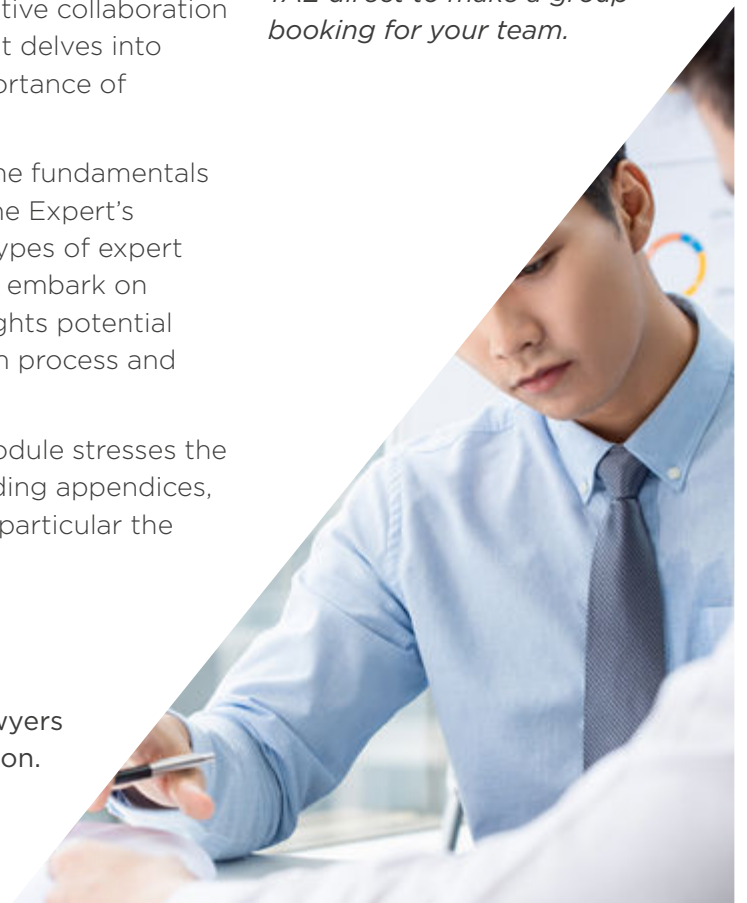
PRACTICAL SESSIONS

THE ACADEMY OF EXPERTS

THE ACADEMY

Located in Gray's Inn, London, TAE was founded in 1987 with the objective of providing, for the first time, a professional body for experts to establish and promote high objective standards.

Although there is representation on the Academy's Council from the legal profession the majority of the officers, including the Chairman, are practising Experts - The Academy of Experts is run by Experts for Experts and those using them.

TRAINING AND DEVELOPMENT

The Academy offers a comprehensive range of training programmes to enable members to develop their expert skills, and undertake Continuous Professional Development activity. Courses range from basic Role and Responsibilities through to the requirements of Procedure Rules and the practice of Giving Evidence.

The Academy is also a training and accreditation body for ADR Neutrals, including Mediators, Conciliators and Expert Determiners.

It publishes and maintains The Register of Qualified Dispute Resolvers and awards the designatory letters QDR to those achieving the approved standard. Standards are enforced in exactly the same way as for experts.

THE JUDICIAL COMMITTEE

TAE's Judicial Committee is chaired by a former United Kingdom Supreme Court Judge and consists of Lords Justice of Appeal and other Senior Judges from the United Kingdom, Hong Kong and Singapore.

The Judicial Committee has been responsible for a number of important documents and guidance notes for experts.

ACCREDITATION

All applicants to The Academy who wish to become Accredited Practising Expert Witnesses undergo a rigorous vetting procedure to ensure standards of excellence are maintained.

This is the process which gives the officially recognised full accreditation as a Practising Expert. Those achieving it are awarded the designatory letters MAE.

Ethical and professional standards are underlined by Codes of Practice and enforced by a disciplinary committee.
