NON-EXECUTIVE DIRECTOR and CHAIRMAN EXPERIENCE

Healthier Lancashire & South Cumbria (NHS), Integrated Care System (ICS) Board – Non-Executive Director/Lay Member (October 2017 to date)

I am currently a Non-Executive Director/Lay Member of Healthier Lancashire & South Cumbria ICS Board. I was appointed to the position in October 2017. The role of the ICS is to provide leadership and development of an overarching strategy for Lancashire and South Cumbria, oversight and facilitation of the delivery of sustainability, transformation and design of the future state of health and care.

NHS Greater Preston CCG - Lay Member for Audit, Finance and Conflicts of Interest (March 2017 to date)

I am currently a Lay Member for Audit, Finance and Conflicts of Interest with Greater Preston CCG. I was appointed to the position in March 2017 for an initial period of 4 years. The purpose of the Audit Committee is to provide assurance to the Governing Body and Member's Council on the design, implementation and effectiveness of internal controls and to provide scrutiny over the discharge of the CCG's statutory functions, including the delivery of financial duties and address Conflicts of Interest.

NHS England Independent Review Panel Chair for Continuing Healthcare Costs (April 2014 to March 2017)

NHS England Independent Review Panel Chair for Continuing Healthcare Costs covering the North of England. This required me to Chair a panel which provides the final stage of appeal for Continuing Healthcare Costs. The Panel, after holding a meeting to which both Claimant and Clinical Commissioning Group (CCG) are invited, then assesses both the process followed and the eligibility criteria to determine an individual's right to Continuing Healthcare Costs. The Chairman then prepares a report setting out the decision of the Panel, either to confirm the original decision as sound, or recommend it as unsound and due for reconsideration.

Chairman NHS Lancashire Audit Committee (April 2013 to June 2013)

Responsible for the delivery and adoption of the statutory audited accounts of the 5 Primary Care Trusts (PCTs) in Lancashire. All 5 PCTs achieved their control surpluses and recurrent balance. Total budget for the 5 PCTs was £2.7 billion. The work involved liaison with internal and external auditors and Directors of Finance. Both to ensure compliance with Financial Standards and Auditing Standards but also as the body charged with Governance for Statutory Audit Purposes.

Non-Executive Director of the NHS Lancashire Cluster Board, Audit Clair and Locality Lead, Central Lancashire Primary Care Trust (September 2012 to March 2013)

Appointed as the only NED of Central Lancashire to the Cluster Audit Board with responsibility for Finance and as Lancashire Cluster Audit Chair. Setup a system of Local Assurance to ensure transition from Primary Care Trusts (PCTs) to CCGs including an integrated Risk Register. Involved the CCGs in Local Audit Committee Meetings from inception to ensure the smooth flow of governance. Organised and Chaired the quarterly Lancashire Cluster Audit Committee Meetings setting out a framework for Governance which reported to the Lancashire Cluster Board to provide assurance.

Non-Executive Director and Chairman of Audit Committee, NHS Central Lancashire Primary Care Trust (2006 to 2012)

Appointed at formation in September 2006, as one of only two NED Board Members. After qualifying as a Chartered Accountant (ICAEW) with Spicer & Pegler (now Deloitte), Mr Cherry worked in a managerial capacity with Price Waterhouse (Kenya), Commonwealth Development Corporation (Tanzania, Solomon Islands, Vanuatu) and KPMG. Formerly Senior Manager responsible for the North West forensic accounting department of KPMG, he formed one of the first practices specialising in forensic accounting in 1988. The business currently employs some 10 staff.

Mr Cherry has acted as an Expert Witness in several thousand cases involving forensic accounting. He has been instructed by both claimant and defendant solicitors to advise the Court on claims for loss of profits and other matters as a Forensic Accountant and Expert Witness. He has been instructed as a Joint Expert on many occasions. In addition, he has been instructed by The Criminal Injuries Compensation Authority to advise on quantum of loss of earnings in criminal cases.

He has given evidence in The Royal Courts of Justice on several occasions, together with many appearances in the High Court, Crown Court, County Court, Tax Tribunals and Employer Tribunals.

Mr Cherry is a qualified arbitrator and a panel member of the President's referral scheme of the Institute of Chartered Accountants in England and Wales. He has carried out appointments and many referrals.

In addition to his Forensic work, Mr Cherry is a Registered Auditor and has a commercial practice as a Chartered Accountant carrying out accountancy, tax and audit work for a wide range of clients.
